## **EDUCATIONAL CONDITIONS**

## Russian Musical Center 2025-2026 Academic Year

 RMC offers music school educational programs, general music education, art and teaching of foreign languages in accordance with the terms listed below.

Therefore, in consideration of the premises and mutual covenants set forth in this agreement the parties agree on the following.

- 2. RMC is obliged to:
  - 2.1. Admit a previously interviewed child to school departments when vacancies are available;
  - 2.2. Issue a certificate (Certificate of Sharjah Private Educational Authority, Sharjah, UAE on assignment of a certain class), as well as the Certificate of the Children's Music School named after. S. Prokofiev, Ekaterinburg, Russian Federation (only for music departments when studying under the Russian Music School Program) upon successful completion of the course:
  - 2.3. Holding a place for a student while been absent providing RMC has had the necessary notification or explanation and on the condition that the payment was made. The teacher is not liable to make up classes missed by any student been absent from school. Classes missed due to the teacher will be replaced at a time convenient for the student.
- 3. The parents are obliged to:
  - 3.1. Ensure the student's attendance according to the timetable (**Duration of lesson is 45 min. In case of a student been late, the lesson will end as scheduled without replacement of tuition time missed**);
  - 3.2. Payments to be made on time;
  - 3.3. Inform the administration and the teacher of valid absences;
  - 3.4. Show respect to teachers and administration;
  - 3.5. Control the behavior of their children while being in RMC premises and rectify any damage of school property caused by their children. RMC are only responsible for students who are attending scheduled lessons. The responsibility of children who are at school before or after schedule lessons is with the parents or acting guardians.
- 4. The student is obliged to:
  - 4.1. Attend all assigned classes;
  - 4.2. Take his or her studies seriously, be active during classes, and diligently do all assigned work;
  - 4.3. Do not bring chewing gum, seeds, chips, and drinks in glass bottles on the premises of the school;
  - 4.4. Do not damage the school property.
- 5. Fee:
  - 5.1. Annual fee Dhs 210;
  - 5.2. Tuition fee throughout the year:
    - 5.2.1. Payment is for the academic year according to the price list (Payment must be made 1 month in advance and be paid in equal monthly installments before the 20<sup>th</sup> of every month from September to June inclusively (9 months), regardless of the number of lessons in the current month. In the case of non-payment before the 20<sup>th</sup>, the student will not be allowed to attend lessons. Missed lessons will not be replaced.
    - 5.2.2. Payments for general music education department are hourly, according to the price list. Payments must be made in advance failure to make the required payment will result in the refusal of student attending lessons.
    - 5.2.3. Exceptional case of non-payment are considered on the basis of written application by the parents to the administration of RMC, together with an indication of the causes and exact date of payment.
  - 5.3. Exams (only for students following the Russian Musical School curriculum):
    - 5.3.1. Entering the 1st grade of RMC Dhs.105;
    - 5.3.2. End of the year exams Dhs.265;
    - 5.3.3. Graduation exam Dhs.315.
- 6. RMC preserves the right to reject a student from class in case of:
  - 6.1. Inability to cope with the workload due to regular absences (more than 4 missed lessons for a month);
  - 6.2. Breach of parental and student obligations specified in points 3 and 4;
  - 6.3. Default of payment, according to point 3.2.
- 7. Any statements or actions that offend the nationality, religion, culture of the participants in the educational process are strictly prohibited (in accordance with Federal Decree Law No. 2 of 2015 "On Combating Discrimination and Hatred"
